Sub: Approval Letter for recognition to Vikrant University, Gwalior as per Section 7(1) (i) of the Advocates Act, 1961 for the purpose of conferring the Degrees in Law and letter for extension of approval of affiliation for imparting 3-year LLB course and 5-year BALLB with intake of one section of 60 students in each course alongwith one additional section with intake of 60 students i.e. two sections of 60 students in each course with regularisation being done for the academic year/s 2023-24 and 2024-25 and approval of affiliation being granted for academic session 2025-26 subject to compliance of Rules Education, 2008 of Legal circulars/directives/guidelines/notifications issued from time to time by the Bar Council of India with respect to maintenance of standards of Legal Education.


Sir/Ma'am,

This is to bring to your kind knowledge that the Standing Committee of the Legal Education Committee of the Bar Council of India in its meeting dated 24.5.2025 has considered the inspection report of School of Legal Studies, Vikrant University submitted by the Inspection Team.

The CLE is a constituent unit(approved under Section 9A of MPPURC) of Vikrant University, which is a State Private University established under Madhya Pradesh Act No. 25 of 2022. The CLE converted into State Private University in September 2022 as per Madhya Pradesh Act No. 25 of 2022.

The Vikrant University, Gwalior, M.P. being a new University has applied for recognition as University as per Section 7(1)(i) of the Advocates Act, 1961 to award degree in law and approval for extension of approval of existing one section of 5-year BALLB and one Section for 3 year LLB with intake of 60 students in each Section.

The CLE has also applied for additional new one section for 5-year BALLB and two sections for 3-year LLB.



Earlier the CLE was known as Vikrant Institute of Law, Gwalior and was affiliated to Jiwaji University and was given provisional approval of affiliation vide letter dated 04.6.2024 for imparting three year LLB degree course with intake of one section of 60 students and five year BALLB integrated degree course with intake of one sections of 60 students for the academic year 2022-2023.

It is seen that the CLE had not obtained BCI approval from the academic year 2023-24 and 2024-25 and also requested for regularization of 3-yearLLB course and 5-year BALLB integrated course from the academic session 2023-24 to 2024-25. The requisite fee has been duly paid by the CLE till the academic session 2025-2026.

It is observed that the College had taken admission in 3-year LLB course and 5-year BALLB integrated course, without approval of BCI from the academic session 2023-24 to 2024-25.

This is in violation of Chapter III, Rule 14 of Rules of Legal Education which stipulates a minimum suspension for two academic years.

After consideration, recognition has been granted to School of Legal Studies, Vikrant Universityas per Section 7(1) (i) of the Advocates Act, 1961 for the purpose of conferring the Degrees in Law.

Further, keeping in view the interests and future of the studentsthe academic year/s 2023-24 to 2024-25are being regularised and extension of approval of affiliation is being granted for academic session 2025-26 for imparting 3 yearLL.B degree course and 5-year BALLB integrated coursewith intake of one section of 60 students in each course alongwith one additional section with intake of 60 students i.e. two sections of 60 students in each course subject to the conditions as imposed by the Inspection Team of BCI and additional conditions imposed by the Standing Committee in order to ensure compliance with Rules of Legal Education 2008 and other stipulations/enumerations as per Rules of Legal Education & other guidelines/circulars issued in this regard from time to time by Bar Council of India.
